DRAW for ENTRIES: will be held that evening at 7:00 p.m. at **504 North Blvd.,
McHenry, IL** to determine which dogs will participate. The public is invited. Entries
will be NOTIFIED BY PHONE, EMAIL AND MAIL of their status as soon as possible
after the draw. Entrants may also call the Test Secretary at **847-602-7518** from 8:00 p.m.
to 9:00 p.m. on Thursday, October 1, 2020. Non-participating alternates' fees will be
returned within one week after the test, unless participant requests the entry be returned
sooner.

ALL CANCELLATIONS of entries must be made in writing to the Test Secretary and
received prior to the stated date and time of the closing of entries. Cancellation by email
will be accepted as in writing notice.

DRAW FOR TRACKS: 8:00 a.m. for TD/9:30 a.m. for TDX, Burlington Prairie Forest
main pavilion entrance. First track will run immediately after, conditions permitting.
Drawing will be held at the main entrance pavilion.

INCLEMENT WEATHER: In the event of extreme weather conditions, the Club may
take such action as necessary to protect the health and safety of the dogs, handlers and
judges, including postponement or cancellation of the test.

LOCATION: From I-90 Westbound: Take the Hwy 47 exit and go south on 47. Travel
3.4 miles to Hwy 72 and turn right. Travel 6 miles and turn left onto Walker Rd. Travel
1.5 miles and turn right onto Lenschow Rd. Travel ½ mile and turn left onto Engel Rd.
proceed south, the preserve entrance is on the right. From I-90 Eastbound: Take the
Genoa Rd. (County Road 4) exit and go south on Genoa Rd. Travel 11.5 miles to Genoa,
where the road becomes Hwy 72. Continue east on Hwy 72 another 5 miles to Engel Rd.
and turn right. The road dead-ends at Lenschow Rd. Turn left and then immediately
turn right onto Engel Rd. The preserve entrance is on the right.
